

include incomplete, narrow, and missing sidewalks, tiered and inaccessible sidewalks on Main Street, and high curbs and a lack of curb cuts throughout town. Community members also noted poor visibility at intersections such as Fair Street and Main Street, and poor conditions on roads such as Frontage Road, Jackson Street, and Pearl Street. There is also a need for safe access to community amenities such as the city pool, the soccer fields, and the medical center.

Transportation Inventory and Analysis

Knowledge of the transportation systems in and around a community is critical for sustainable transportation enhancement planning. Moville's transportation systems include state highways, roadways, pedestrian walking and biking routes, and a river.

US Highway 20 and State Highway 140 intersect at the southwest corner of the city and the West Fork Little Sioux River runs along the western side of the city.

The visioning design team met and coordinated with lowa Department of Transportation (DOT) personnel, the Woodbury County Engineer, and local officials to identify existing, past, and future transportation system capital improvements, maintenance, and other transportationrelated constraints and opportunities in the Moville area.
